- Annual Meeting / Gala Contracts Ray presented the Board with the contract proposals for the proposed venue for the Annual Meeting/Gala from Great Marsh Estate, which the venue contract amount is \$3,685.50. Additionally, he presented the contract from the proposed cater for the Annual Meeting/Gala from Serendipity Catering for an amount of \$15,499.96. Ray noted that the Events Committee had reviewed the contracts and had recommended to the Board that they approve the contracts and engage Great Marsh Estate and Serendipity Catering. - An update on the digital directory was provided, which noted Sales to Date of \$21,390 or \$3,390 over the prior month. A review of the advertisers and the ad sizes was reviewed.
- Staffing changes were discussed.
- An update on the Fall Festival noted that to date a total of 75 of the available 130 booths have been reserved for total income of \$13,125.
- It was noted that staff submitted names and contact information of the Chamber member insurance professional to the WiseChoice Healthcare Alliance.
- An overview of the website analytics was provided to the Board.
- Information on the RetirePath Virginia State Facilitated Retirement Savings Program was provided.
