COALITION LETTER IN SUPPORT OF HB 2195/SB 1470

Tuesday, January 31, 2023

On behalf of the undersigned coalition of industry, business, and workforce leaders in the Commonwealth, we write to express our support for HB 2195 and SB 1470, which will consolidate Virginia's fragmented and siloed workforce development programs that currently sit across 13 agencies and six secretariats, under one new agency. By adopting the Workforce Development Transformation legislation, the Commonwealth has the unique opportunity to improve the delivery of its workforce development services, up-skill and re-skill job-seekers, and prepare its workforce for the jobs of today—and tomorrow.

The Commonwealth is facing unprecedented critical workforce shortages across many sectors and regions. While many workforce development programs provide a great service, the system as a whole is a set of channels with limited connectivity, creating a fragmented system that limits the potential future prosperity and opportunity for both Virginians and the businesses that drive the Commonwealth's economic vitality. Since the COVID-19 pandemic, 120K fewer Virginians are participating in the Commonwealth's labor force compared to pre-pandemic levels, with a labor force participation rate of 63.6% overall in Virginia.¹

Combining many of these programs under a single agency will optimize workforce readiness for Virginia's current and future jobs. The proposed creation of the Virginia Department of Workforce Development and Advancement (VDWDA) will provide:

- More efficient program delivery and increased workforce participation, fostering greater business investment, and, ultimately, a stronger economy for all Virginians;
- Data-driven insights that will improve the delivery of skill-building and workforce preparedness services through leveraging innovative data gathering and analyze best practices;
- A centralized strategy balanced with regional flexibility, ensuring programs and services remain consistent with the needs of regions across Virginia;
- Program development that better aligns with the needs of businesses and the ability to scale programs that work; and
- A set of measures and metrics focused on jobs filled and people retained in the workforce, with greater accountability of the results.

The time to make a lasting investment in Virginia's long-term economic growth and workforce development is now.
