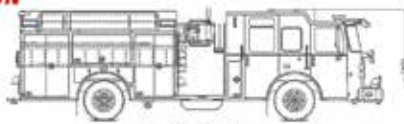

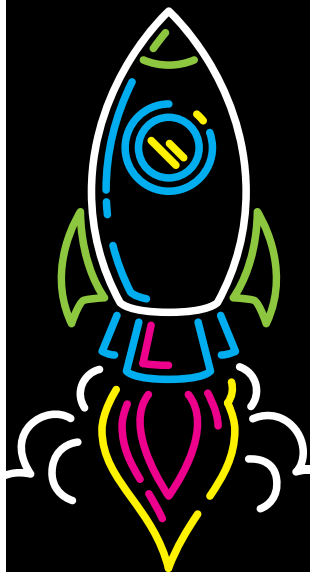

Christopher Todd Butler was born and raised in Fauquier County and after graduating from Fauquier High School he attended Lord Fairfax Community College to study law enforcement and then began a ten year career in public service as a Deputy Sheriff with the Fauquier County Sheriff's Office. After an injury forced his retirement from law enforcement, Mr. Butler became a professionally Certified

Occupational Safety Specialist. Today he is the Safety Director for S.W. Rogers Company, Inc., and is responsible for overseeing the overall health, safety and welfare of the company's workforce.

Mr. Butler was first elected to represent the Lee Magisterial District on the Fauquier County Board of Supervisors in 2016, and was sworn in for a second term of public office in January 2020. He served as Vice Chairman in 2017, and then presided as the Chairman of the Board for two consecutive terms in 2018 and 2019.

Mr. Butler sits on several committees including the Fauquier County Agricultural and Forestal District, Agricultural Advisory Committee, Broadband Authority, Personnel Committee, Public Safety Committee, Quantico Civilian/Military Community Relations Executive Council, Rappahannock-Rapidan Regional Commission, Rappahannock River Basin Commission, Regional Jail Board, and Transportation Committee.

Mr. Butler is quite active in the community. He attends Bealeton Baptist Church, and serves on the Fauquier Farm Bureau as well as the Cedar Grove Cemetery Board of Trustees. Previously he served on the Fauquier Crime Commission and is a former member of the Fauquier County Fair Board. Mr. Butler enthusiastically supports the Remington Volunteer Fire Department, the Remington Fall Festival, and the Sumerduck Ruritan Club.

A fourth generation farmer, Mr. Butler and his wife Lisa live in Remington with their two children and their golden doodles Duke and Pippa.

VETERAN HONOREE

COOPER L. WRIGHT



Cooper L. Wright was born in Mineola, NY on May 28, 1944. He graduated with the West Point Class of 1966. Following completion of Airborne and Ranger training, became a combat engineer platoon leader in Germany. He then served back to back combat tours in Vietnam for which he received two Bronze Stars and three Air Medals.

Upon his return to the United States, he attended Purdue University where he obtained a Master's Degree in construction management. He was then assigned to the Los Angeles Engineer District where he served as a project manager responsible for the construction of a \$7 million postal facility in Van Nuys, California. He returned to West Point in the mid 70s where he was an assistant professor of mathematics and where he met and married the love of his life, Linda.

After graduating with honors from the US Army Command and General Staff College, he was assigned to the Armor and Engineer Board at Fort Knox, KY where he worked with the Israeli Army to develop countermining battle drills that were later used by U.S. forces during the Gulf Wars. His final Army assignment was as Director of Test and Evaluation at the US Army Engineer School at Fort Belvoir, Virginia. He retired from the Army in 1986.

In retirement, he worked for a number of defense industry firms supporting the National Missile Defense program.

Cooper and his wife Linda moved to Warrenton in 2002 and loved its small town environment. For nine years, he served on the Board of Directors for the Piedmont Symphony Orchestra, including two years as its President. He is proud of how the PSO continues to serve the community by mentoring band and orchestra students in our junior and senior high schools.

His real passion, however, was mentoring hundreds of young men and women from Fauquier, Culpeper, Rappahannock, and Greene counties seeking admission to West Point.

DEPARTMENT OF FIRE, RESCUE & EMERGENCY MANAGEMENT LIFE SAVING AWARD



Greetings,

In the early morning hours of August 6, 2020, the engine crew assigned to Station 11 (Orlean) was dispatched to a reported structure fire with occupants trapped on Leeds Manor Rd. The Wagon responded quickly and followed closely by the tanker.

Upon their arrival Wagon 1111's officer, **Lt. Jeremy Leonard**, reported heavy fire in the main floor of the structure and two occupants stranded on a second floor balcony with no way to safely exit. Lt. Leonard directed crew members, **Technician II Nicholas Baer** and **Technician Edward Sonifrank**, to place a ladder and rescue the occupants and tasked the just-arriving tanker with fire suppression duties.

Two adults and two dogs were removed from the structure by ladder and escaped any serious injury. The tanker crew, led by volunteer Lt. Robert Tarr, was able to quickly contain and extinguish the fire with the assistance of Orlean Chief Johnny Ray Kearns. Additional fire units from Warrenton, Marshall, and The Plains also responded. The occupants were transported to Fauquier Hospital for observation and the two dogs were fostered by a volunteer member of Orlean Volunteer Fire until they could be returned to their owners.

The decisions made by Lieutenant Leonard and the quick actions of Technician II Baer and Technician Sonifrank was undoubtedly instrumental in saving the lives of two Fauquier Citizens. I am nominating them for the Fauquier Chamber's Life Saving Award.

MERITORIOUS UNIT CITATION



The successful rescue operation described above would have required far greater personal risk without the coordinated efforts of Tanker 1111's crew. Their actions contained the fire until the residents could be safely removed. For this, I also nominate **Lt. Robert Tarr, Firefighter Mary Tarr, Firefighter Tibby Clegg, Firefighter Michael Flammia**, and **Chief Johnny Ray Kerns** for the Meritorious Unit Citation.

The outstanding performance and of these men and women reflect great credit upon themselves and the Fauquier County Fire and Rescue system.

MERITORIOUS AWARD



Detective Corporal Michael Gemmell has been serving with the Virginia Internet Crimes Against Children (ICAC) Task Force for approximately 6 years. The ICAC Task Force helps Federal, State and local law enforcement agencies enhance their investigative responses to offenders who use the Internet, online communication systems, or computer technology to sexually exploit children.

As a member of ICAC, Det. Cpl. Gemmell receives information from the National Center for Missing and Exploited Children, which has led to the investigation of several cases in Warrenton. In the past year, Det. Cpl. Gemmell's investigations have yielded 14 felony counts of possession of child pornography and 5 felony counts of distribution.

Det. Cpl. Gemmell's immense contributions has helped identify offenders who prey on children who have been victimized. His professionalism and devotion to duty reflect greatly upon himself and his example emulates the Warrenton Police Department's mission to provide a safe and secure environment.



On October 30, 2020 **Sergeant Justin Pierce** was attending training at the Northern Virginia Criminal Justice Academy. While leaving the restroom, a firearm discharge went off from one of the stalls. Sergeant Pierce immediately observed a firearm on the floor inside the handicap stall. Sgt. Pierce began asking if the person inside the stall was okay and what had happened. The person inside the stall was a Deputy from another jurisdiction who stated that he had dropped his gun. When the Deputy inside the stall opened the door, he touched his leg and observed that he was bleeding. After securing the Deputy's Firearm, Sergeant Pierce began applying a tourniquet and stayed with the deputy until medics arrived.

If it wasn't for Sgt Pierce actions a fellow law enforcement officer could have died due to the amount of blood he lost.



FAUQUIER COUNTY SHERIFF'S DEPARTMENT

LIFE SAVING AWARDS

Criteria – *This award is provided to individuals who, through their extra ordinary efforts, were able to take actions that resulted in the saving of a life or lives.*



ECSIII Renee Settle: On February 2, 2020, ECSIII Settle took a 911 call for a cardiac arrest. ECSIII Settle determined that victim was having agonal breathing and quickly began CPR instructions until EMS personnel arrived on scene. ECSIII Settle remained calm throughout the call and was able to talk the caller through CPR, aiding in saving the patient's life.



DEP Charles Acres: On February 26, 2020, then ECSI Charles Acres answered a 911 call for a woman in labor. He quickly started giving instructions while the ambulance was being dispatched. Within three minutes the baby was out with the cord wrapped around its neck. ECSI Acres could hear it crying and kept calm and proceeded to instruct the caller on removing the cord from the baby's neck without cutting the cord. EMS arrived five minutes into the call and the baby was crying loudly by that point. ECSI Acres remained exceedingly calm referred to his EMD cards, giving clear instructions for the entire duration of the call.



10TH ANNUAL VALOR AWARDS



DEP Charles Acres: On March 24, 2020, then ECSI Acres answered a 911 call for an unconscious male that was breathing. Within seconds, Charlie was providing airway control instructions. The caller seemed to be unsure if the patient was breathing or not, but once established that the patient was not breathing, ECSI Acres started CPR instructions and continued until units arrived to take over. ECSI Acres remained calm and without assistance, as all the other dispatchers were tied up.



DEP. Carter Cash: On July 27, 2020 Dep Carter Cash was doing a ride along with a Patrol deputy when they were dispatched to an overdose. The deputy administered Naloxone and Dep. Cash performed CPR. Subject was transported to the hospital.



FAUQUIER COUNTY SHERIFF'S DEPARTMENT

MERITORIOUS SERVICE AWARDS

Criteria – This award is provided to individuals who have demonstrated extra ordinary efforts either at a specific incident or through a series of investigative endeavors.



MDS Arrington: On January 23, 2020, MDS Arrington stopped a vehicle for speeding. The driver advised that his passenger was having chest pains, at which time MDS Arrington requested that rescue respond to the scene. Due to the suspects' suspicious demeanor, MDS Arrington deployed K-9 Bane around the vehicle for a free air sniff where he alerted on the odor of narcotics. Due to suspicious, but not illegal, items located in the vehicle, MDS Arrington took photos of the items, the vehicle, and both occupants of

the vehicle. MDS Arrington sent the photos and information to Crime Analyst Kristi House, who created an informational flyer and sent it to other law enforcement agencies and the Fusion Center.

The next day there was a home invasion in another state. Because of the information provided in the flyer, another agency was able to immediately establish a vehicle and a suspect, who was later arrested. Because of MDS Arrington's training, knowledge, and experience, he was able to identify and properly document suspicious activity in order to assist with other possible law enforcement investigations.



CPL Joseph House: On January 10, 2020, then DFC Joseph House was investigating a missing juvenile. Suspecting that the juvenile was in the company of two adults with whom DFC House had had prior interactions with he went to various known locations. Through surveillance he was able to locate the juvenile. Further investigation led to the discovery of a large amount of narcotics, paraphernalia and money.

10TH ANNUAL VALOR AWARDS



CPL Nathaniel Minton: On February 14th, 2020, then DEP Minton was attacked by a mental health consumer who was trying to get out of custody. The subject was also trying to grab at DEP Minton's firearm while attempting to flee. DEP Minton was able to successfully maintain control of the subject and his firearm while taking repeated blows to the head and face until help could arrive to assist him. DEP Minton's actions prevented the incident from becoming a possible large scale manhunt. DEP Minton's action also

prevented injuries or even death given the incident that happened in the hallway of the Fauquier E.R. in front of the nurse's station with hospital staff in close proximity.



SGT John Coppage and MDS

Vanessa Breedlove: On 06/26/2020

SGT John Coppage and MDS

Vanessa Breedlove responded to a report of a suicidal person/welfare check. SGT Coppage and MDS Breedlove immediately requested the assistance of a K-9 team as they began conducting a search of the

property. VSP TPR J. Lewis and his K9 as well as TPR D. Mabie arrived to assist in the search. The K-9 tracked to the location of the victim who was unconscious and unresponsive. Naloxone was administered and the victim was transported to the hospital.



FAUQUIER COUNTY SHERIFF'S DEPARTMENT

MERITORIOUS UNIT AWARD

Criteria – This award is provided to a full unit that was involved in an incident or incidents that involved extra ordinary efforts to rescue, defuse and/or create a safe and secure situation.

ECSIV Samantha Ashby, MDS Emmie Dean, ECSIII Kim Malloy, ECSI Carter Cash:

On 01/08/2020, ECSIV Samantha Ashby took a call for a shooting. MDS Emmie Dean, who was working part time in Communications, quickly toned out the call to WPD and got all units responding. ECSIII Kim Malloy, the supervisor that night, was dispatching FCSO units and got them started in that direction, putting them on an alternate channel and patching that channel with WPD. ECSI Carter Cash was dispatching Fire and Rescue and within moments of WPD arriving on scene and finding multiple victims, was able to add additional ambulances to the call and keep them updated. ECSIV Ashby, and ECSIII Malloy made calls to the hospital, Aircare, Fairfax 1, Park Police, the SDO, WPD Chief, K9 units, property managers, surrounding agency hospitals, and local businesses for video footage, sent hits to Fairfax, sent a BOLO to surrounding jurisdictions, and took other calls; ECSI Cash managed multiple fire and rescue units staging, on scene, and with landing zones, and MDS Dean handled both WPD and FCSO units on the patched channels as they cleared the apartment, searched the area, and conducted K9 tracks.



10TH ANNUAL VALOR AWARDS

1SGT Lance Davenport, SGT Kevin Ryan, MDS James Arrington and DET Lucas

Jacobs: On October 11, 2020, 1SGT Lance Davenport, SGT Kevin Ryan, MDS James Arrington and DET Lucas Jacobs responded to assist the Warrenton Police Department with what was initially reported as a Burglary in Progress. The subject, who had been identified as a mental health consumer, was reportedly armed and had barricaded himself in an apartment.

Deputies immediately deployed a perimeter around the structure. When the subject exited the apartment and repeatedly failed to comply, the deputies formed a stack utilizing a shield and combination of TASER, less lethal, and lethal options. Their tactically sound decisions and prompt decisive actions were instrumental in bringing a potentially dangerous situation to a quick resolution without injury to the public, the offender, or themselves.

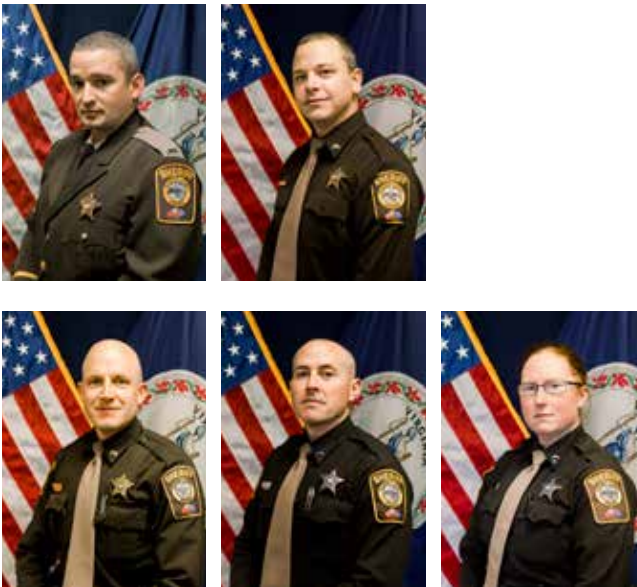


LT Kristi Kiernan, MDS Marissa Efaw, DET Robert Lewis and DFC Gary Jenkins:

On October 20, 2020 units responded to a weapons violation call. Upon arrival, it was discovered that the subject was suffering a mental health crisis. LT Kristi Kiernan and MDS Marissa Efaw were able to communicate with the subject to deescalate the situation while DET Robert Lewis and DFC Gary Jenkins maintained cover. The teamwork by the Deputies involved to deescalate the situation without force while avoiding injuries to themselves or anyone else is commendable.



LT David Lee, CPL Aaron Vescovi, CPL Alex Armstrong, DFC Andrew Stribling, and DFC Kaycee Huston: On October 21, 2020 LT David Lee, CPL Aaron Vescovi, CPL Alex Armstrong, DFC Andrew Stribling, and DFC Kaycee Huston responded to a domestic disturbance where the subject was armed and had communicated her intent to kill responding law enforcement officers, the other parties and then herself. DFC Stribling, CPL Armstrong and DFC Huston determined that the subject was suffering a mental health crisis and attempted to de-escalate the situation while LT Lee supervised the scene and CPL Vescovi gathering information to relay back to the deputies. Due to the teamwork of these deputies the subject was taken into custody without incident.



Criminal Investigations Division: Since August of 2019, the members of the Criminal Investigations Division have successfully investigated seven homicides and assisted the Warrenton Police Department with two additional homicides.

The Area 12 Office would like to nominate **Senior Trooper C.R. Scally** for his efforts in recovering a Silver Alert subject. Senior Trooper Scally successfully located the subject (Wayne Sauder) of a Silver Alert out of Maryland who was suffering from dementia, diabetes and colon cancer by maintaining contact with the Montgomery County Police Department who were actively pinging the cell phone of the subject.

While the initial call came in the subject was still in Fauquier County just outside of Warrenton. Senior Trooper Scally travelled outside of his assigned duty post and activated emergency equipment as he needed to locate and stop the subject's vehicle and bring needed medical assistance to the subject just prior to the Madison County line on Route 29.

The family was notified by Trooper Scally and once the subject was transported to Culpeper Hospital, Trooper Scally followed the subject there and further met with the family and debriefed them on what had transpired.

Mr. Sauder who while suffering from the aforementioned ailments was also disoriented and dehydrated, he believed he was in Maryland when Trooper Scally located him and in obvious need of medical attention.

Senior Trooper Scally's actions to track down the vehicle which included taking the initiative to leave his duty post which represented a service above and beyond what was expected and exemplified the virtues of our department and its personnel, a fact that was not lost on the very thankful family of Mr. Sauder.



The Area 12 Office would also like to nominate **Senior Trooper Jeffrey W. Palmer** for his phenomenal efforts to insure highway safety in Fauquier County.

Trooper Palmer exhibits an extraordinary dedication to the promotion of highway safety, largely through his enforcement efforts which remained constant even throughout the COVID pandemic.

Trooper Palmer aggressively enforces moving violations of reckless driving and speed, issuing 197 reckless driving and 652 speeding summonses respectively. However, Trooper Palmer also devoted his attention to operator licenses, equipment violations, inspections and seatbelts/child restraints which brought his performance year total to 1,055 summonses to include 8 criminal arrests and 1 DUI arrest.

Trooper Palmer truly seeks to have a positive impact on highway safety within the Commonwealth of Virginia and his enforcement actions personify a dedication to the welfare of its occupants and set a tremendous example to his fellow troopers.

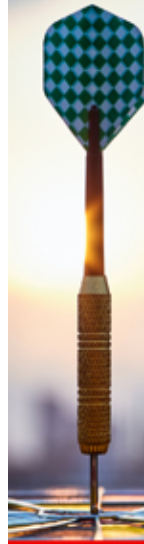
